



ISAZISO NGENHLOSO YOKUQASHISA UMHLABA KWI-WARWICK MALL (PTY) LIMITED

1. Lesi isaziso sokuthi uMkhandlu waseThekwini (“uMkhandlu”) unenhloso yokuqashisa umhlaba, ochazwe kabanzi ngezansi, uqashisela i-Warwick Mall (Pty) Limited (Inombolo yokubhaliswa u-2006/023113/07) isikhathi esiyiminyaka engamashumi amahlanu (50), lingekho ilungelo lokuvuselela, ngemali yokuqasha eyokhokhwa kanye eyisamba sezigidi ezingamashumi amabili nambili nezinkulungwane ezingamakhulu amahlanu zamaRandi (R22,5m), ukuze kwenziwe intuthuko ehlongozwayo kulendawo eku-Warwick.
2. Lomhlaba oyingqikithi yalenhloso yokuqashisa uchazwe kabanzi ngesiNgesi kanje, *Proposed Lease (A) over Remainder of Erf 1 Durban; Registration Division FT, in the Durban Entity, Province of KwaZulu-Natal, in extent approximately 1,4920ha, as depicted in Plan S.H. 9616*, kanye namalungelo asemoyeni avikelekile ngaphezu kwezindawo zokuhamba ngezinyawo eziya ku Julius Nyerere Avenue kanye no Market Road.

ANNEXURE “A”

ISITATIMENDE SOLWAZI

Izizathu Zenhloso Yokuqashisa

- I-South African Rail Commuter Corporation (“SARCC”) yaqashisela i-Warwick Mall (Pty) Limited (“uMthuthukisi”) amalungelo asemoyeni aseningizimu yesiteshi esiku-Berea Road ukuze kube nentuthuko yokwakha izindawo zokudayisa nezamatekisi.
- UMthuthukisi weza eMkhandlwini nesiphakamiso sokuthi aqashe indawo eyaziwa ngokuthi i-*Early Morning Market*, kanye namalungelo asemoyeni angaphezu kwemigwaqo eyakhelene nalendawo, ngenhloso yokwenza intuthuko eyodwa exubene, ezokwanelisa izidingo zoMthuthukisi noMkhandlu.
- Kunentuthuko enkulu yezindawo zokudayisa esendaweni engango 30,000m² ehlelwe ukwakhiwa esigabeni sokuqala 1, ezoba semhlabeni we-SARCC kanye noMkhandlu elinganiselwa esambeni samaRandi esiyizigidi ezingamakhulu amathathu namashumi amahlanu (R350m).

Ubungcono Obulindelekile eMkhandlwini Ngenxa Yokuqashisa

- Intuthuko yesamba esingu-R350m ye-Warwick Mall.
- UMthuthukisi uzokwakha futhi apha the i-renke yamatekisi angamakhulu amane. Ukuphathwa kwale-renke kuyoba yizindleko zoMthuthukisi futhi kube ngaphansi kwemibandela ekuyovunyelwana ngayo noMkhandlu.
- UMthuthukisi uzokwakha i-‘Masigiye Square’, indawo enkulu yomphakathi ehamba ku-Julius Nyerere Avenue iye endaweni evulekile yomphakathi esemngceleni ka-Wills Road. Izindleko eziphathelene nalokhu kuyobanjiswa ngazo ngokuthi uMthuthukisi akhiphe izindleko eziphathelene nokwakhiwa kwezindawo zokuhweba eziyikhulu namashumi amahlanu (150) kulendawo.
- UMthuthukisi uzokwakha indawo yokuhamba esuka ku-Brook Street, ihambe phezu kwendawo ebekelwe ujjantshi ye-SARCC, inikeze indlela yokufika e-renki yamatekisi, eyobe isiphuma ku-Khuzimpi Shezi Road ngalokho yenze ngcono ukuhamba kwezinto zokuthutha umphakathi ku-Warwick.
- UMthuthukisi uzoxhuma ngebhuloho u-David Webster Street bese anikeze abahamba ngezinyawo indlela eqondile esuka e-Victoria Street Bus Rank Site, idlule kwintuthuko eku-Warwick Mall iye e-renki yamatekisi engaphezulu kanye nasesiteshini esiku-Berea Road, ngokwenzenjalo ididiyele izindlelo zokuhamba komphakathi.
- I-Masigiye Square izophathwa uMthuthukisi ngaphansi kwemibandela ekuvunyelwene noMkhandlu.

- Uma uMkhandlu ukwazile ukuvumela uMthuthukisi ukuthi aqale ngo-April 2009, uMthuthukisi uthembisa ukuqeda isigaba sokuqala salentuthuko ngaphambi kokuqala kwemidlalo yeNdebe yoMhlaba yeFIFA ngo 2010.
- Eminyakeni emihlanu sibhalisiwe isivumelwano salukuqashisa okuhlongozwayo, okungenani ubunikazi boMthuthukisi obungama-*percent* angamashumi amahlanu nanye (51%) buyobe busezandleni zalabo ababecindezekile phambilini.

Izimali Ezilindeleke Ukwamukelwa uMkhandlu Ngenxa Yokuqashisa

- Kuyokhokhwa imali yokuqasha eyodwa engu-R22,5m okuyisamba esikahle sokukhokhela ilungelo lokuqasha uma kuqhathaniswa namanani ezindawo ezifanayo, okuhlelwe ukuthi ikhokhwe izigaba ezintathu kanje:
 - R500,000.00 uma kusayinwa isivumelwano sokuqashiselana;
 - R11,0m ngomhlaka 1 May 2010; no
 - R11,0m ngomhlaka 1 December 2010
- UMthuthukisi uzokwakha i-renke yamatekisi esigabeni sesibili sesakhiwo esiphezu kwe-*Early Morning Market Site*, ukuze kusizakale uMkhandlu. Leyontuthuko izoba ngangesamba sika-R62,8m empahleni yomphakathi (i-renki yamatekisi), futhi uMkhandlu uzokhipha isamba esingu-R24,0m.

Inzuzo Noma Ukulahlekelwa KoMkhandlu Ngenxa Yokuqashisa

- Ukukhokhwa kwemali yokuqasha eyodwa engu-R22,5m.
- Ukwakhiwa kwe-renke yamatekisi angamakhulu amane (400), okuzolingana nokutshalwa kwemali engango-R62,8m empahleni yomphakathi i-renki yamatekisi), futhi uMkhandlu uzokhipha isamba esingu-R24,0m.
- Izindleko ezing-R23,2m zokwakha indawo yokuhamba esuka ku-Brook Street, ihambe phezu kwendawo ebekelwe uJantshi ye-SARCC, inikeze indlela yokufika e-renki yamatekisi zizokwabiwa ngokulinganayo phakathi koMkhandlu noMthuthukisi.
- Kuzoba nenzuzo ngomnotho eya eMkhandlwini nakwi-Warwick Precinct ngenxa yentuthuko yezindawo zokuhweba zesamba sika-R350m.
