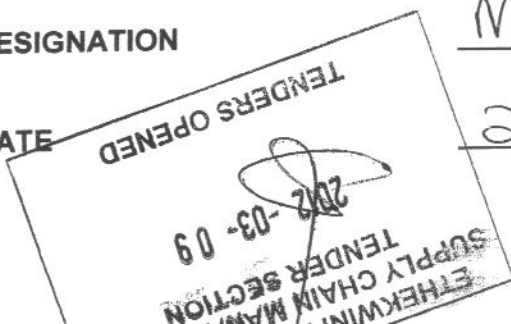



It is an accepted norm in the industry that the services of Officers engaged in the function of VIP Protection Officers to be paid as a higher rate than Officers engaged in escorting and guarding functions. This arises from the fact that such officers are trained in different competencies, are required to have additional skills, abilities and training. In light of this, an additional category of "A" Grade Security Officer (VIP) is catered for in the pricing structure, as reflected above.

It is also recorded that a company wishing to tender for ONLY VIP Protection Schedule 49 will not be required to complete Annexure H1 and Annexure H2.

However, companies who wish to tender for Schedule 49 (VIP Protection), completion in full of this Supplementary Annexure H4 is compulsory, as indicated in Clause 1.8 as read with Clause 4.26 of the Technical Specifications, to Enquiry/Tender 1W-7620 document.
